| General Terms and Conditions | |
|-------------------------------------|--|
| QA 1 | <p>Raw Material or chemical suppliers must furnish Certificate of Analysis, here-in called COA, on all delivered materials.</p> <p>For assembly suppliers, each shipment shall be accompanied by material certification(s), as applicable, of the individual components that comprise the assembly. The material certificate shall reference the material specification and lot traceability to the purchase order.</p> |
| QA 2 | Chemical blenders should document the inspection of all raw materials used in end product and should prepare a COA to submit at time of delivery. COA of the raw material in blended products should be maintained and the supplier shall assume all financial responsibility for replacement, rework, and material when customer contract requires the supplier to submit all applicable COA's for raw materials prior to production and if production begins without first receiving approvals from the customer |
| QA 3 | Any delay in shipment for any reason has to be conveyed to customer as soon as the delay is known by the supplier. |
| QA 4 | Any change to the contract requirements by the supplier must be approved by the customer in writing. |
| QA 5 | All information in the contract must be held in confidence by the supplier and no third party request for information will be authorized unless instructed in writing by customer or its representative. All documents to be retained for 10-year min unless extended retention is requested by customer quality flow diagram. At the end of this 10-year period, the supplier shall contact the organization for disposition of all records. |
| QA 6 | In addition to our right of access, the supplier agrees to right of access for our customers, or regulatory agencies to all facilities and records in the performance of this contract. |
| QA 7 | Manufacturer of certain raw materials must have a quality maintenance system in place in compliance to AS9003, AS9100, or ISO9001 if stipulated by customer via contract and if that was requested by our customer. |
| QA 8 | Subcontractors are required to notify customer prior to transferring any work to a new facility. Customer will determine prior to the transfer if subcontractor may perform the work at a new facility. |
| QA 9 | Supplier must notify of any nonconforming product or raw material. |
| QA 10 | Supplier must get prior approval of any nonconforming material to be used in blended product or material to be delivered. |
| QA 11 | Requirements of the supplier must flow down to sub-tier suppliers of the applicable requirements in the purchasing documents, including key characteristics to be met where required and must follow positive foreign object damage (FOD) control processes. |
| QA 12 | Requirement for supplier personnel awareness 1- their contribution to product or service conformity; 2— their contribution to product safety; 3— the importance of ethical behavior. |

| QA 13 | <p>As APPPLICABLE, a copy of the seller's First Article Inspection Report in accordance with AS9102 shall be sent with each initial shipment of a part number. Subsequent FAI shall be performed under the following conditions unless these conditions are waived by the buyer.</p> <ul style="list-style-type: none"> a) Engineering changes (configuration changes affecting fit, form and/or function) require partial FAI for those characteristics affected by the change. b) If major changes are made in the seller's method of manufacturing and/or tooling, a new FAI shall be performed in accordance with AS9102. c) If the production of the product has been dormant for 2 years or longer, a new FAI shall be performed in accordance with AS9102. |

| QA 100 | Processing suppliers must furnish processing certifications to the purchase order requirements, and shall not process any parts for which they are not certified or approved. Nadcap and/or other specifications approval are required. Acceptable quality system requirements are AC7004 or ISO9001, or AS9100 any revision. QA 3, QA 4, QA 5, QA 6, QA 8, QA 9, QA 10, QA 11, QA 12. |

| For Raw Material suppliers, the following are the minimum requirements & Counterfeit Must Comply to AS5553 and AS6174. | |

| QA 200 | Raw Material suppliers must furnish COA to the purchase order requirements and shall not supply material for which they are not certified or approved. When noted on our purchase orders, raw material supplier must use USA domestic material or DFARS 252.225-7014 compliant its equivalent. Acceptable quality system requirements are AC7004 or ISO9001, or AS9100 any revision. QA 3, QA 4, QA 5, QA 6, QA 8, QA 9, QA 10, QA 11, QA 12 |
